## The Rector's Report

*From his fullness we have all received, grace upon grace. (John 1:16)*

Grace, upon grace, upon grace. My prayers every day begin with thanksgivings for God's bounty here at St. Mark's. I am full-up, truly joyful about the start of my ministry with you all.

The welcome of the transition committee, our first Sunday together, the parish retreat, our Stewardship in-gathering, the Vestry retreat in November, the many fellowship meetings and pastoral conversations that I have had with you, leave me feeling that St. Mark's is a community alive in the Spirit. We have extraordinary staff, beautiful and well-maintained facilities, strong worship, music, financial management and governance. But I notice God's gifts most when I hear how the members of our parish are committed to doing God's work-worshipping, praying, studying, loving one another and reaching out beyond our walls to our neighbors.

I see that we are starting new ministries, and deepening our commitment to ones that define us. I love our jail ministry, our commitment to Abode and the Opportunity Center, I love our new work with the Day Workers' Center. The Becoming Beloved Community Task Force is expansive in its vision for how the work we started with Sacred Ground can continue with community forums, films and discussions. The Men's Breakfast, the Women's Tea (and planned Retreat), the Book Groups and Bible Study are all centers of connection and care. Our music program supports our joyful worship and is working on new collaborations. New ideas about parent groups, young adult fellowship and the new nursery affirm our identity as a multi-generational church where every person young and old is recognized as a beloved member of God's family.

I know God's bounty when I see the hundreds of neighbors who use our facilities, who bring music, dance, healing conversations and movement to so many neighbors. I know that I am in the right place when I pray with the people who stop by hungry for a connection and needing a grocery card or a little financial support. I know that we are not alone as I begin to meet with sister Episcopal Churches on the Peninsula and our multi-faith community who are committed to God's justice.

In our world today, there are economic, social and political forces that divide and isolate us. There is the harsh reality of injustice, poverty, climate devastation and violence. But St. Mark's is, and can continue to be, a place of hope that banishes fear, connection that overcomes isolation, and love that reflects God's love for all of God's creation.

I am so happy to be with you all and look forward to our ministry together in 2026

## Wardens and Vestry Report

The Vestry is St. Mark's governing body and working Board of Directors. The St. Mark's Vestry has 12 elected members who serve staggered three-year terms, plus the Rector. The parish typically elects four Vestry members at the annual meeting. These new members are installed on Pentecost, usually in late May or early June. The Vestry, including outgoing and incoming members, and clergy gather for an annual retreat near Pentecost to reflect upon the spiritual and practical health of St. Mark's parish and plan for the coming year.

Typically two members of the Vestry hold the office of Warden. During our rector search and transition, we have had three wardens. The Senior Warden is usually appointed by the Rector and the Junior Warden is traditionally elected by the Vestry. One of the Wardens presides at monthly Vestry meetings. The Wardens and the Rectors make up the Vestry Executive Committee (VEC). The VEC meets weekly to review parish matters and prepare the agenda for upcoming Vestry meetings.

The current Vestry members include **Jonathan Luk (Senior Warden), Cheryl Miller (Junior Warden), Tom Jenkins (Junior Warden), Crystal Larsen, Randy Smith, Jonake Bose, Martha Chan, Marina Martin, Susan Dansker, Iain Greensides, Stuart Sailer, Tom Schnaubelt, and The Rev. Kirsten Snow Spalding (Rector)**. Meetings include Rev. Kirsten, Rev. Nancy, Susan Pines (Treasurer), and Martha Leveque-Eichhorn (Clerk of the Vestry).

The theme for Vestry for much of 2025 was "transition." Reflecting over the past year, it is remarkable how much good work was accomplished even as we waited and looked forward to our new rector. Continuing from Fall 2024 into the first few months of 2025, Vestry worked with the Rector Search Committee as they prepared the application materials for a new rector, including the St. Mark's parish profile based on numerous surveys and round tables. In February, the diocese published our parish profile and we awaited submission of applications. During this waiting time, Vestry continued to work with Interim Rector Rev. Nick Roosevelt to prepare for the arrival of our new rector. Plans were initiated to convert the first-floor room next to the stairs to a nursery and renovate the adjacent bathrooms. Fabrication of new way-finding signs, new landscaping of street-facing property, and updating of campus wi-fi began. We attended to creating and updating various policies, such as the Personnel Manual, and engaged in a plan to ensure completion of Safe Church Compliance Training by those parishioners for whom it was required. In March and April, the Search Committee reviewed all applications received, completed interviews and reference checks, and sent finalists to Vestry. Over several weekends in May and early June, Vestry interviewed the final candidates, culminating in the call and acceptance of our new rector, The Reverend Kirsten Snow Spalding! As we waited for her to arrive, we hosted Hotel de Zink for two months and put on an exuberant Community Fair and Jazz Eucharist.

In September, we said good-bye to Interim Rector Rev. Nick with a vestry-led, joyful "grand agape" in gratitude for his hard work and commitment to St. Mark's for over two years. Vestry formed a "transition team" to support Rev. Kirsten's arrival and beginning of her ministry, and we welcomed her with an all-parish potluck on October 5<sup>th</sup>, her first Sunday with us. And then, we were off and running—launching an earlier stewardship campaign, gathering for the parish retreat, walking to raise funds to end hunger in the Crop Walk, celebrating the in-gathering of pledges with the Stewardship Brunch, participating in

Friendsgiving, leading into Advent with Advent Eve, the Greening of the Church, and celebrating Jesus's birth with our pageant and Christmas services.

For 2026, the Vestry is focused on improving the structure and communications of our outreach and in-reach ministries so that we can do more of what matters most. We are so grateful to parishioners' continuing efforts and dedication to participating in ensuring the health and vibrancy of St. Mark's and its ministries during the transition over the past two-plus years. We are excited to see how God guides us into the future. The Vestry welcomes input from the parish. Please contact any Vestry member with suggestions, concerns, or questions. Our purpose is to serve and support the parish and its mission.

## Diocesan Delegation

In 2025 St. Mark's was represented by the following elected delegates to Diocesan Convention: Matthew Burt, Jonathan Harvey, Romain Kang, and alternates Bert Bell, Brie Linkenhoker, and Terry Moore. Along with Rev. Kirsten and Rev. Liz Milner, Jonathan, Matthew, and Terry attended the Convention in person at Grace Cathedral on October 18—they were joined by Romain for the virtual session the evening prior.

The major focus of the Convention was the launch of the diocesan Strategic Vision Plan, which was presented by various members of the committee that developed it, including our own (now Rev.) Debie Thomas. The plan identified seven focus areas for work across the diocese in the next three years: Christian Formation & Leadership Development, Congregational Development, Mission Congregations, Finances, Multicultural & Multilingual Ministries, Repair & Healing, and Experiencing & Embodying the Love of Jesus Beyond Our Church Doors. Additionally, the Convention passed several canon changes, elected nominees to offices within the diocese, including our deputation to General Convention (our churchwide governing body), and passed the budget and financial resolutions. Four topical resolutions were also passed, forming an assessment formula task force, advocating for social justice and affordable housing, and mandating pension participation for non-stipendiary clergy.

As always, I and my fellow delegates welcome questions and suggestions for our participation not only in Diocesan Convention but also in the Peninsula Deanery.

## Who are we

## Purpose

Meeting monthly, we review St. Mark's Episcopal Church's main financial investments and programs; review the annual budget recognizing income/expense exposures and make recommendations to Rector/Vestry; support the Treasurer in preparation of the St. Mark's Episcopal Church annual budget; review requests for funding from commissions and make recommendations to Rector/Vestry; create new programs to develop the overall financial strength and stability of St. Mark's.

## 2025 Highlights

Finance commission meetings continued to be an excellent forum for the rector and former interim rector, treasurer, and members to review St. Mark's Episcopal Church's main financial programs and investments, review performance against our budget, and just talk about financial issues and matters. Here are a few key items:

- Supported Treasurer in Development of St. Mark's Annual Budget that included revisions
- Monitored adaptation to a changing parish demographic and declining pledging units
- Jonathan Luk continued as Vestry Liaison
- Supported 564 Colorado Corp Management that had full occupancy through 2024
  - Maureen Kennedy continues as Business Manager
  - Continued dividend to St. Mark's of \$4K per month for 2025
- Maintenance Funding: Mary Murphy provided reporting to Finance
- Offered New Vestry Financial Training as needed
- Maintained a Balanced Budget by Effective Monitoring
- Completed quarterly reviews with Endowment Trust
- Planned Giving: David Kennedy continued to lead the initiative

## Endowment Trust

### Who are we

### Purpose

The Trustees of the Endowment Trust are responsible for the administration and governance of the assets held in the Endowment Trust. The purpose of the Trust is to provide and encourage gifts to the endowment fund of St. Mark's.

### 2025 Highlights

- Elected three new Trustees in February 2025
- Monitored performance of the endowment portfolio; the portfolio increased by 12.7% for the FYE 9/30/25, with total assets increasing from \$1,571,136 to \$1,783,469
- Managed interaction with the Domestic and Foreign Missionary Society, the missionary organization and corporate body of the Episcopal Church, which is responsible for investing the endowment funds
- Maintained quarterly financial reporting of the portfolio performance, distributable amounts, cumulative draw amounts, and withdrawals and contributions
- Provided periodic updates to Finance Committee
- With Vestry, managed a \$40,000 withdrawal from the Major Maintenance Fund, used for rectory repairs
- With Vestry, managed two contributions, aggregating \$65,000, into the General Fund; the funds were gifts from the estates of Carol Cook and Buffy Welch
- Created a "Key Facts and Processes" document which provides background information on the Endowment Trust, DFMS, and a summary of the Endowment Trust's key responsibilities

## 2026 Objectives

- Continue to provide monitoring of the endowment portfolio performance and maintenance of quarterly financial reporting, distributable amounts, cumulative draw amounts, and withdrawals and contributions
- Continue to provide periodic updates to the Finance Committee
- Ensure new Trustees are familiar with Endowment Trust responsibilities
- Create standard forms with gifting instructions for future contributions
- Increase parish awareness of legacy gifting
- Update our processes, including clearer guidance on processing of contributions

## 564 Corporation

### Purpose/Description

564 Colorado Corp. is a for-profit corporation that is 100% owned by St. Mark's Episcopal Church. All of 564's assets are invested in a Palo Alto home at 2727 Gaspar Court. The corporation has 3 directors: Paul Milo, Jonathan Luk, and David Kennedy, who are responsible for managing the corporation mainly by providing fiscal oversight and property management of 2727 Gaspar Court. Maureen Kennedy handles the financial and administrative work for 564. Paul Milo provides primary tenant management. A set of by-laws, on file in the church office, governs the activities of the corporation. 564 Colorado Corp. provides, subject to adequate cash reserves, a monthly dividend to St. Mark's Church.

### 2025 Highlights

2025 was a stable year for 564 Colorado Corp. with the tenant continuing, and minor maintenance needs for the property.

- The corporation provided a monthly dividend of \$4000 to St. Mark's.
- The corporation updated its cash reserve goal to, and has been able to maintain, a minimum of nine months operating expenses as vacancy reserve, a \$25,000 operating maintenance reserve (for ongoing upkeep or refurbishment), and a capital reserve for near-term expected major maintenance needs (current significant example of roof replacement expected within a few years, estimated at \$45,000).
- Property maintenance in 2025 included pest control, sprinkler system repair, and minor door repair.
- The current tenant, who moved in November 2021, continued with a term through May 2026. A small pet amendment was added.

## **Hopes for 2026**

To continue supporting the Vestry's strategic direction regarding the use of the 564 property. To maintain full rental occupancy and increase the rent if possible depending on the rental market. We will make every attempt to balance the financial needs of the corporation with being a compassionate landlord. We will attempt to complete all needed repairs and updates to the property while maintaining a minimum of nine months operating expenses in cash reserves, as well as sufficient operating maintenance and major capital maintenance reserves.

The commission oversees all major and regular maintenance and repairs with the rector, the staff, and the parish leadership. Also, the group manages the replacement of the facility assets, organizes three parish workdays, and supports the Membership Commission.

### **2025 Highlights**

- Researched possibilities for both HVAC and Parish Hall acoustics.
- Performed necessary work in Rectory for handover from Rev. Nick to Rev. Kirsten.
- Added windows to office doors per insurance company safety report.
- Repaired or replaced problematic campus doors.
- Updated the 2025 Reserve Analysis.
- Improved the lighting situation in the Chancel.
- Installed new wayfinding signage on campus, including labels for doorways.
- Replaced fragmented Wi-Fi networks with a uniformly available campus-wide network.
- Renovated bathrooms and Children's Nursery within the Church.

## 2026 Plans

- Fix lighting and audio issues in the gallery.
- Continue researching options for both HVAC and Parish Hall acoustics.
- Research painting/plaster plan for inside of Church.
- Review stained glass windows with a new vendor.
- Update the 2026 Reserve Analysis.

## Stewardship Commission

Our mission is to invite all parishioners to be good stewards, i.e., to tend to, or be caretakers, of our faith community.

To fulfill this mission, the Stewardship Commission's plan of activity includes three phases. First, we tend to, or care for, each member of the parish through a personal contact in August by phone if possible to check in and invite everyone to participate in the new church program year. This early phone call also allows us to update contact information and learn of any moves, etc. so that our parish roster is more accurate. Second, in late October through November, we invite all parishioners to care for the parish as a whole by making a promise of support in terms of time, talent, and financial resources for the coming year. Finally, in May, at the end of the year, we call once again to thank parishioners for being part of our community and to invite them to the annual church picnic to celebrate another year of blessings at St. Mark's.

## 2025 Activities and Results

In line with this time of transition to a new rector, the theme for 2025-2026 was "A Future with Hope." This theme was narrowed down by Rev. Nick through a pre-bought package and chosen by Rev. Kirsten before her official start. Our stewardship campaign is focused on gratitude for all that we receive from being part of the St. Mark's community. We seek broad participation among parishioners at whatever level of support is possible for each person. Every pledge, regardless of amount, is welcome as an important symbol of commitment to St. Mark's – a pledge of time, talent, and treasure.

- This year's campaign piloted three new changes, meant to address recent challenges with the pledge campaign.
  - The first change was the addition of Pledge Ingathering Sunday, held on November 2, wherein parishioners were invited to bring their pledges forward to be blessed. This change led to having 86% of our pledge goal raised with 101 pledges in hand.
  - The second change was a formal deadline of pledges to be included in the parish budget. This year the deadline proved to be more of a stimulus than last year. While pledges are welcome at any time of year, shifting our pledging habits to a deadline left a clear picture for the vestry, budget committee, and the parish.

- The third change was initiated by Rev. Kirsten and it was an early kickoff on September 21st. Due to other food-related events we opted for a Stewardship Kick off Agape that was a huge success! We also shortened the time the pledge season ran to six weeks with an unofficial deadline a few weeks later.
- In the fall, the Finance Commission, Vestry, and clergy set a pledge goal of \$634,400, which represented a 3% increase over our pledge budget for 2025.
- Stewardship materials created by the clergy to provide clear and comprehensive information about the financial needs for 2025 were mailed in mid-October.
- Parishioner Brie Linkenhoker delivered an inspiring stewardship sermon where she shared her background and love of this community.
- The annual Stewardship Brunch was held on November 2nd, to celebrate the Pledge Ingathering service. Approximately 110 parishioners attended the brunch which was prepared and served by over 17 parishioners and six vestry members. We again served soup and salad with some of the soup and the salad coming from Ada's.
- Mego Tracy wrote the articles in the *Messenger* that appeared over the first five weeks of the stewardship campaign. Announcements were also made each Sunday with updates on progress and encouragement.
- Over 30 volunteers, Vestry members, and Stewardship Commission members followed up by phone and email with each parishioner to be sure stewardship materials had been received and to answer any questions about the budget and stewardship process.
- Once again we leaned heavily on our office manager, Wenjing Li, to keep us up-to-date on the number of pledges and on progress toward our financial goals. Wenjing did an amazing job of learning the various databases, processing all of the articles and reminder messages included in the weekly St. Mark's *Messenger*, and sending email communications to the parish. We could not have managed the stewardship effort without her as an amazingly capable and cheerful partner.
- Thank you cards were created, then addressed by the office, signed by the Rectors, and sent by Wenjing, to every parishioner who pledged.
- Our 2026 Pledge Campaign ended with 113 pledges totaling \$631,782.00 or 99.6% of our pledge goal. On another positive note, we received pledges from 11 new families and 58 parishioners were able to increase their pledges as a positive sign of the generosity of our parish. St. Mark's is truly remarkable in that a large percent of our active parishioners make some level of financial commitment each year. **We give thanks to everyone in the parish who pledged their participation in church activities and/or financial support for 2026.**

### **Volunteer Participation in Stewardship Activities**

Good stewardship requires the dedicated efforts of a large number of people. We deeply appreciate the efforts of everyone who participated this year. The campaign could not be done without their support, and we encourage everyone to become involved and share the responsibility for caring for the parish. It is a great way to minister to our community and to get to know others outside the comfort of your immediate circle of friends.

In particular, we are looking for a co-chair of the commission for next year, and for someone to work on the management of various parish membership lists and the calling efforts. Please consider joining this team next year!

Thanks to everyone who pledged, preached, cooked and served, wrote, called, and reminded. We are honored to have served on the Stewardship Commission.
